
# Habitat for Humanity® of Morrison County



### **HFHMC Service Area**

- Morrison County has a population of 34,250
- 2024 AMI is \$65,000
- Largest community is Little Falls, population 9,000
- Top employers: Camp Ripley, Little Falls School District, St. Gabriel's Hospital, Wabash, AirBorn, Walmart





### **HFHMC Info**

- HFHMC was established in 1998, and built the first house in 1999
- We have built 24 homes in 6 communities: Little Falls, Royalton, Pierz, Motley, Swanville, and Randall. We currently have lots available in Upsala and Little Falls
- 75% of our applicants are single parent families with one income and the majority work in healthcare



## Habitat Funding

- Grants from MN Housing, Habitat MN, Morrison County, and MC United Way
- State Housing Tax Credit
- Local 3<sup>rd</sup> party financing F&M Bank
- Corporate and private donations
- Events
- Current Mortgage Payments



### Ladies' Luncheon

- Seats are \$30/ea
- The table hostess invites their friends and dresses the table according to whatever theme they have chosen
- Event includes a catered lunch and speaker, as well as raffle baskets, jewelry raffle, dessert auction, live auction, designer purse silent auction
- We typically have around 15 volunteers, plus waiters
- Net Income ~ \$15,000



# Luncheon Breakdown of Activities

### **Jewelry/Designer Bags**

- Jewelry from local jeweler; 3 sets; \$500; tickets sell \$20 each
- Silent Designer Purses 6 donated bags-\$875

### **Live/Dessert Auction**

- 12 Desserts
- 12 Live auction items
  - Tour Right Bike
  - Outdoor Pizza Oven
  - Travel tickets
  - Quilt
  - Spa Day
  - Pair of Kayaks

### **Raffles: Basket/U Choose**

- Sell 10 tickets for \$20 to drop in jars near basket
- All donated baskets -
- Income alone \$8,621
- U Choose \$20 ticket gets your choice of live auction item

### **Golf Tournament**

- We do a 4 person scramble and try to limit to 18 teams at \$100/person
- Games and contests on the course
- Hole sponsorships available for \$100 and sponsors can set up a swag table
- Raffle baskets \$20 tickets
- We serve brats and ice cream on the course (both donated) and lunch after
- We typically have around 10 volunteers
- Net income ~ \$ 12,000-15,000



# Annual Appeal

- Our fall newsletter is sent in November to our mailing list with a report from the Executive Director and an appeal for donations.
- We include a self-addressed envelope for donations.
- Net income \$10,000-15,000



# Annual Appeal Breakdown

- November 2024
  - 1,500 newsletters
  - 61 donors including 3 new donors
  - \$10,080
  - Gifts vary from \$20 to \$3,000
  - Cost approx. \$600 for printing & mailing
  - IRA donations on-going annually
    - \$50 \$2,500 range individual gifts



# **State Housing Tax Credit Contribution**

- Taxpayers contribute to MN Housing instead of MN Department of Revenue
- MN Housing sends funds to HFHMC at end of project
- Tax credit certificate is received from MN Housing
- Contributions can be from \$1,000 \$2,000,000
- Total statewide cap is \$9,000,000
- HFHMC has received \$75,000 so far from this program
